- (f) Amend its resolution so that the resource consent application to Environment Canterbury for Main Road three laning embankment slope be 1 in 2, rather than 1 in 3.

Councillor Buck moved that the Council approve a pedestrian crossing, controlled by traffic signals be installed on Clyde Road located at a point 23 metres north of its intersection with Hinau Street.

The motion was seconded by Councillor Gough and when put to the meeting was declared **carried** on division No. 2 by 11 votes to 3, the voting being as follows:

Against (3): Councillors Broughton, Chen and Johanson.

Note: The question was asked whether staff have met all of the requirements for consultation under the Local Government Act 2002 and the response was yes.
