## 1. PURPOSE AND ORIGIN OF REPORT

- 1.1 The purpose of this report is to obtain the Board's approval to three new road names in the Prestons Subdivision off Prestons Road.

## 2. EXECUTIVE SUMMARY

- 2.1 Three new road names are required to complete Stage 2 of the subdivision.

## 3. BACKGROUND

- 3.1 Three new road names have been submitted to complete the remainder of stage two of the subdivision. The names proposed are
- **Kawharu Street** which will link Taiore Crescent and Ruapani Street;
  - **David Palmer Street**, a short street between Metehau Street and Te Korari Street; and
  - **Te Rau a Kaka Street.**

I have requested backgrounds for the three streets, particularly as to Te Rau a Kaka standing alone without the suffix "Street". Deleting "Street" would simplify the name.

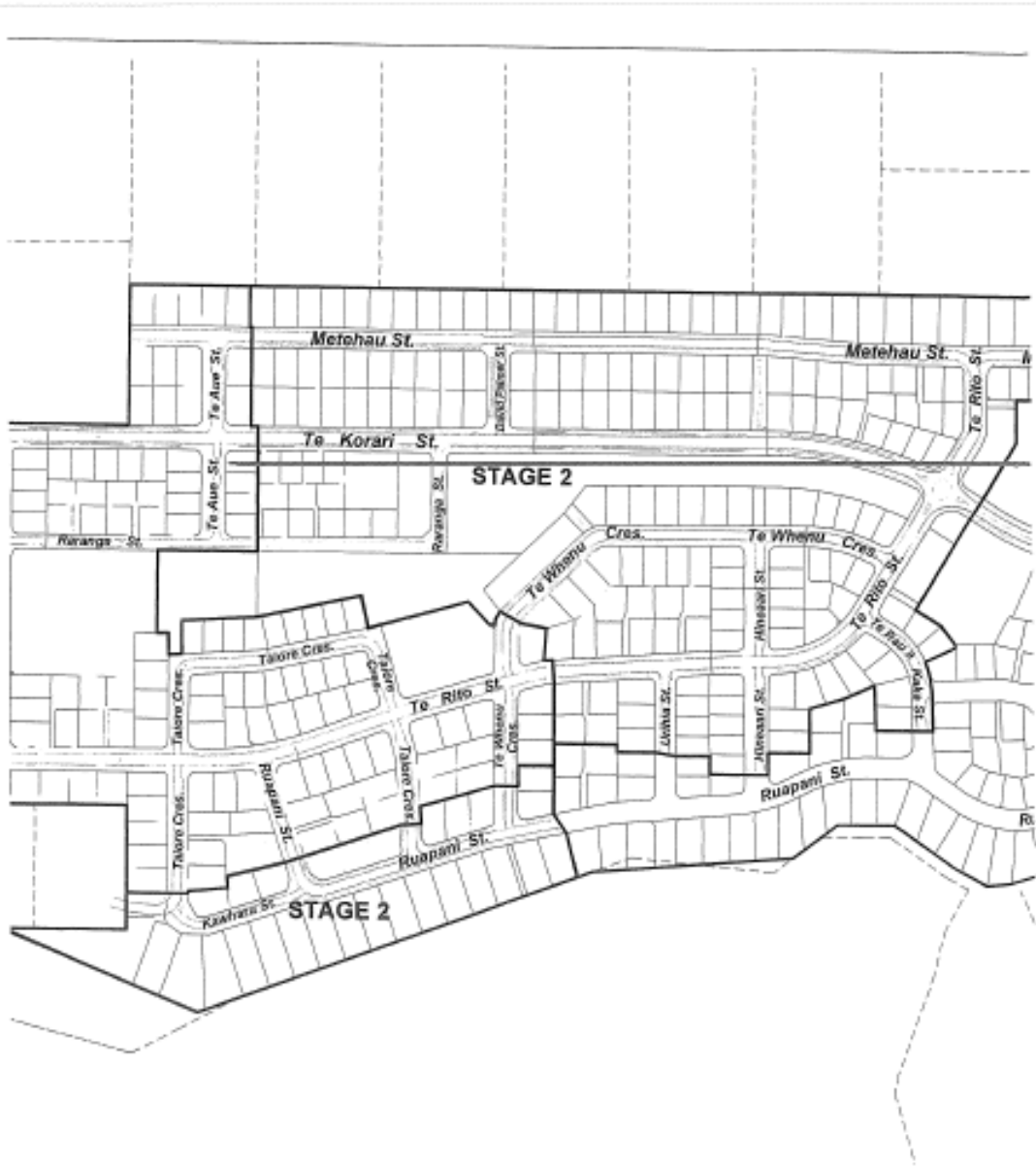
## 4. FINANCIAL IMPLICATIONS

- 4.1 There are no financial costs to the Council. The administration fee for road naming is included as part of the subdivision consent application fee and the cost of name plate manufacture is charged direct to the developer.

## 5 STAFF RECOMMENDATION

It is recommended that the Board:

- 5.1 Approve the names Kawharu Street; David Palmer Street and Te Rau a Kaka or Te Rau a Kaka Street in the Prestons Subdivision off Prestons Road.
