

Terms and Conditions for *Our Christchurch Magazine* Competitions

1. Instructions on how to enter the Competition form part of these terms and conditions.
2. By entering a Competition, you are deemed to have read, understood and accepted these terms and conditions.
3. Unless otherwise stated, registration or entry in each Competition is limited to one per person. Multiple entries will be excluded.
4. Only people over the age of 18 years old are permitted to enter any Competition. Christchurch City Council (CCC) may require an entrant to provide proof of identification and age.
5. To qualify for a prize, the winner must be a New Zealand resident and in Canterbury, New Zealand, to accept the prize. Prizewinners may be asked to verify their physical address.
6. Employees of CCC or any Council Controlled Organisation, their immediate families and the prize sponsor/supplier are not permitted to enter any Competitions.
7. CCC, at its sole discretion, reserves the right to extend or discontinue a Competition at any stage, for any reason.
8. CCC reserves the right to exclude any person from participating in a Competition on reasonable grounds. CCC reserves the right to refuse to award any prize to an entrant who the *Our Christchurch Magazine* editor decides, in his/her sole discretion, has violated the rules, gained unfair advantage in participating in the Competition or won using fraudulent means.
9. Entrants are responsible for ensuring the correctness of all details on entry forms. No responsibility can be taken by CCC for any incorrect information received.
10. CCC takes no responsibility for any inability by an entrant to enter, complete or continue a Competition due to equipment or technical malfunction, or other lack of access, including inadvertent disconnection, Acts of God or otherwise.
11. Proof of posting or emailing an entry cannot be taken as proof of receipt by the Council.
12. The winner of each prize will be the first valid entry randomly drawn from all valid entries correctly submitted during the Competition period.
13. By entering, the entrant grants CCC exclusive permission to use an entrant's name, photograph and likeness in *Our Christchurch Magazine* as required.
14. All reasonable attempts will be made to contact the prize winner within 5 business days of the Competition closing date. Should attempts to contact the winner fail, another winner may be drawn within 7 working days of the Competition closing date.
15. CCC will, at its sole discretion, determine how prizes are delivered to prize winners. When prize winners are contacted, they may be advised how the prize will be delivered. CCC is not responsible for any damage to prizes arising during delivery, or mis-delivery or non-delivery by the carrier. Couriers are instructed to have all prizes signed for on receipt. Failure to obtain a signature may result in the prize being returned to CCC. Under such circumstances, another winner may be drawn.
16. Prizes are not transferable, exchangeable or negotiable and are not redeemable for cash. CCC reserves the right to substitute a prize of an equal or similar value.
17. Prizes may also be subject to any standard terms and conditions of the sponsor, supplier or promoter supplying the prizes.
18. CCC will not be responsible in any way whatsoever to prize winners for any costs related to travel or accommodation in accepting or redeeming their prizes, unless otherwise stated in the Competition.

19. All decisions made by the editor of *Our Christchurch* Magazine are final and no correspondence will be entered into.
20. To the fullest extent permitted by the law, CCC will not be liable for any loss, costs or damage, or for personal injury as a result of any Competition promoted in *Our Christchurch* Magazine.
21. In terms of the Privacy Act 1993, unless explicitly stated in the Competition entry details, information supplied by an entrant as part of a Competition (for example, email address, phone details) will not be collected or used for any other purpose except to ascertain a prize winner.
