## PUBLIC NOTICE

The Christchurch City Council hereby gives notice that it intends to take the following actions:

### **Proposed Reserve Declaration – Part of South New Brighton Park**

To declare the parcel of land specified in Schedule A below Recreation Reserve in accordance with section 14 (1) of the Reserves Act 1977 (Act) to reflect the existing use and management of this land for outdoor recreation as defined by section 17 (1) of the Act.

Schedule A

Pt Lot 84 DP 829 of approximately 0.0784 hectares, contained in Certificate of Title CB306/218.

### **Proposed Change of Reserve Classification – Bridge Reserve**

To resolve to change the classification of the parcel of land specified in Schedule B below from Recreation Reserve to Local Purpose (Utility) Reserve in accordance with section 24(1)(b) of the Reserves Act 1977 to reflect the proposed change in use of the reserve as a stormwater storage basin. This parcel is in the part of Bridge Reserve on the northern side of Bridge Street and is currently classified as Recreation Reserve.

Part of Pt Res 1579 of approximately 2.5716 hectares, contained in Certificate of Title 45A/1241.
