HALSWELL DOMAIN PROPOSED LEASE TO HALSWELL BOWLING CLUB FOR BOWLING GREENS AND CLUBROOMS

This is public notice in accordance with the requirements of section 54(2) of the Reserves Act 1977 (the Act) that the Council is proposing to grant a ground lease to Halswell Bowling Club over part of Halswell Domain for their continued occupation of the two existing bowling greens, clubrooms and associated accessory buildings, and an extension to their leased area on which to construct a third bowling green.

The Halswell Bowling Club's existing leased area is approximately 4370 square metres in area, the current lease for which has now expired. The proposed third bowling green will be an artificial playing surface surrounded by open-style fencing. The existing clubroom building will be extended into this additional leased area by approximately 92 square metres. The third green, and extended building, will occupy an additional area of approximately 1845 square metres. The new total leased area will therefore be approximately 6215 square metres.

Officers will be recommending to the Council that it:

Grant a lease to Halswell Bowling Club pursuant to the requirements of section 54(1)(c) of the Act over approximately 6215 square metres of the land described in Schedule A below, for a period of up to 33 years broken into three terms of 11 years each, the Club having the right to apply to renew the lease after the first two terms.

Schedule A

RS 40337 which is 8.4139 hectares in area held in CT 646/79, a classified recreation reserve vested in the Christchurch City Council pursuant to the Reserves Act 1977.

Lot 1 DP 429188 which is 5582 square metres in area held in CT 517811, a recreation reserve vested in the Christchurch City Council pursuant to the Reserves Act 1977.

Halswell Domain totals 26.2307 hectares in area. There is sufficient existing on-site car-parking to service the additional bowling green. This lease will have no effect on the existing trees, landscaping and other recreational facilities, or the layout of sports fields within the park.
