

## NOTIFICATION OF COUNCILS INTENTION TO CONSIDER THE GRANTING OF A NEW LICENCE AGREEMENT FOR A COMMERCIAL ROPES BASED COURSE AT SEAFIELD PARK SPENCERVILLE – ADRENALIN FOREST LIMITED

Since 1 October 2006 Adrenalin Forest Limited have occupied approximately 5 hectares of Allotment RS 40231, a Recreational Reserve as notified in the New Zealand Gazette 1973/742, to operate a commercial rope based adventure course.

Notice is given that pursuant to Sections 54(1) (d) of the Reserves Act 1977, the Christchurch City Council intends to consider granting a new Deed of Licence for six years to Adrenalin Forest Limited, to enable Adrenalin Forest Limited to continue operating the course.

## REQUEST FOR PROPOSALS FOR A LICENCE TO GRAZE HORSES OR SHEEP ON PART OF 353 OR 361 POUND ROAD

The Christchurch City Council invites proposals for a grazing licence to graze horses or sheep at the above addresses. The land will be available from 1 May 2013. The Council will consider a proposal to graze all parcels of land, or part of the total land package being offered. The purpose of the grazing licence, to be granted under Section 74(2) (a) of the Reserves Act 1977, is to manage and control weed growth. The licence is intended to be for a period of five years commencing on 1 May 2013, finally expiring on 1 May 2018.

The proposal relates to land titles held for Gravel Reserve purposes under the Reserves Act 1977, being part of Part Reserve 1378 and part of Part Reserve 329 as detailed in New Zealand Gazette 1962 page 980 and being approximately 5.545 hectares in total.
