## DRAFT CHRISTCHURCH CITY COUNCIL LOCAL ALCOHOL POLICY (LAP)

The Christchurch City Council is proposing to make a Local Alcohol Policy, under the Sale and Supply of Alcohol Act 2012, that deals with the licensing of premises to sell alcohol. This includes on-licensed premises (such as cafes, bars and taverns) and off-licensed premises (such as bottle stores and supermarkets).

The Council has prepared a draft LAP and is now seeking community feedback on it.

### The draft LAP

The draft LAP for Christchurch City contains the following types of licensing policies:

- Variations on the maximum trading hours set in the Act for on-licences and for off-licences.
- Different maximum trading hours for on-licences in different areas of the city.
- One-way door conditions for premises holding on-licences. These will be mandatory in certain areas of the city and discretionary in other areas.
- Various discretionary conditions for on-licences, off-licences, club licences and special licences.
- Restrictions on the location of new bottle stores and taverns to business zones.
