A progressive reopening of Riccarton Road will occur in an easterly direction once the parade has passed and clean up crews have cleared the roadway.

These closures are proposed to be made under paragraph 11(e) of the Tenth Schedule of the Local Government Act 1974. The proposed closures will apply to all vehicular traffic with the exception of emergency service vehicles and scheduled public transport services.
