



PUBLIC NOTICE OF AVAILABILITY OF LATE SUBMISSIONS AND CORRECTED SUBMISSION AND RIGHT TO MAKE FURTHER SUBMISSIONS

1. On 27 August 2014 the Christchurch City Council publicly notified 12 proposals and associated planning maps to replace some of the provisions of the operative Christchurch City Plan and the Banks Peninsula District Plan. The period for making submissions on those proposals closed on 8 October 2014. Under the provisions of Clause 5(1)(b) of Schedule 3 Canterbury Earthquake (Christchurch Replacement District Plan) Order 2014, the chairperson of the hearings panel has accepted late submissions from Brian Farrant (#1196) and William Thomson (#1197).
2. A submission was lodged by Peebles Group Limited, but was mistakenly published as part of the Peebles Family Trust submission (#1078) when submissions were notified by public notice dated 22 October 2014. As the Peebles Group Limited submission has not been published in its own right, it has now been published as submission #1195 and is subject to further submissions. The period for making further submissions on the Peebles Group Limited submission closes at 5:00 pm on Friday, 28 November 2014.
3. The submissions by Brian Farrant, William Thomson and Peebles Group Limited may be inspected during normal office hours at any of the Council's Service Centre offices, Council libraries and on-line at www.proposeddistrictplan.ccc.govt.nz For details of your nearest service centre or library please telephone 941 8999.
4. The following persons may make a further submission on the submissions by Brian Farrant, William Thomson and Peebles Group Limited:
 - The Minister for Canterbury Earthquake Recovery and the Minister for the Environment.
 - Any person representing a relevant aspect of the public interest.
 - Any person that has an interest in the proposal greater than the interest that the general public has.
 - Christchurch City Council.
5. Any further submission must be limited to a matter in support of, or in opposition to the submissions made by Brian Farrant, William Thomson and Peebles Group Limited and must state whether or not you wish to be heard.
6. The further submission must be served on the Christchurch City Council. A copy must also be served by the further submitter on the submitter within five working days after the further submission is served on the Christchurch City Council.
