



## **PUBLIC NOTICE OF AVAILABILITY OF LATE SUBMISSIONS AND CORRECTIONS TO SUBMISSIONS AND RIGHT TO MAKE FURTHER SUBMISSION**

On 2 May 2015 the Christchurch City Council publicly notified a number of proposals and associated planning maps to replace some of the provisions of the operative Christchurch City Plan and the Banks Peninsula District Plan. The further submission must be served on the Christchurch City Council. A copy must also be served on the submitter within five working days after the further submission is served on the Christchurch City Council.
