## **PUBLIC NOTICE OF AVAILABILITY OF LATE SUBMISSIONS AND RIGHT TO MAKE FURTHER SUBMISSION**

1. Under the provisions of Clause 5(1)(b) of Schedule 3 Canterbury Earthquake (Christchurch Replacement District Plan) Order 2014, the Chair of the Independent Hearings Panel has accepted late submissions from:
  - #5082 Ray Winter who seek to have a site of ecological significance (LP35) fronting Kainga Road deleted from Planning Map 2
  - #5083 Adrian Daly who seek to rezone the property at 38 Waipapa Avenue Diamond Harbour from Residential to Open Space Community Park
2.   - Any person representing a relevant aspect of the public interest.
  - Any person that has an interest in the proposal greater than the interest that the general public has.
  - Christchurch City Council.
4. Any further submission must be limited to a matter in support of, or in opposition to the submission made by Ray Winter or Adrian Daly and must state whether or not you wish to be heard.
5. The further submission must be served on the Christchurch City Council. A copy must also be served by the further submitter on the relevant submitter within five working days after the further submission is served on Christchurch City Council.
