## **PUBLIC NOTICE OF AVAILABILITY OF SUBMISSIONS AND RIGHT TO MAKE FURTHER SUBMISSIONS**

1. On 28 September 2015 the Christchurch City Council publicly notified a proposal for Residential New Neighbourhood Zones at North Halswell and South Masham. The period for making submissions on those proposals closed on 10 November 2015.
2. The submissions received on the proposal for Residential New Neighbourhood Zones at North Halswell and South Masham are now available for public inspection. The submissions may be inspected during normal office hours at any of the Council's service centre offices and Council libraries. 4. Any further submission must be limited to a matter in support of, or in opposition to, any submission made on the proposal and must state whether or not you wish to be heard.
