

## **PUBLIC NOTICE OF AVAILABILITY OF** SUBMISSIONS AND RIGHT TO MAKE **FURTHER SUBMISSION**

- 1. On 2 May 2015 the Christchurch City Council publicly notified the Stage two proposals and associated planning maps to replace some of the provisions of the operative Christchurch City Plan and the Banks Peninsula District Plan. The period for making submissions on those proposals closed on 15 June 2015.
- 2. Under the provisions of Clause 5(1)(b) of Schedule 3 Canterbury Earthquake (Christchurch Replacement District Plan) Order 2014, the Chair of the Independent Hearings Panel has accepted 26 late submissions relating to the proposals contained in Stage two Chapter 6.1 Noise, particularly the provisions relating to noise contours for, and noise from, aircraft engine testing. These submissions are numbered 2091 and 2846 to 2870.
- 3. On 25 July 2015 the Christchurch City Council publicly notified the Stage three proposals and associated planning maps to replace some of the provisions of the operative Christchurch City Plan and the Banks Peninsula District Plan. The period for making submissions on those proposals closed on 4 September 2015 apart from the Coastal Environment proposal (Chapter 19), the closing date for which was 16 October 2015.
- 4. Under the provisions of Clause 5(1)(b) of Schedule 3 Canterbury Earthquake (Christchurch Replacement District Plan) Order 2014, the Chair of the Independent Hearings Panel has accepted late submissions from:
  - #4003 to #4005 Jane Belkin relating to the proposals contained in Stage three Chapter 5 Natural Hazards, particularly the provisions relating to High Flood Hazard Management Areas as they apply to properties at 34 Sloan Terrace and 98 and 100 Hunter Terrace, Christchurch.
  - #4006 New Brighton Surf Bathing and Life Saving Club Inc. which seeks amendment to an objective and policy in Chapter 19 Coastal Environment.
  - #4007 NZ Cashflow Control Ltd, #4008 Denis Harwood, #4009 Westminster Trustee Services Ltd and #4010 - Josephine Lohrey who all seek to amend provisions in Chapter 9, Natural and Cultural Heritage, particularly provisions in 9.1 and 9.2.
- 5. In addition the following submissions on provisions in Chapter 5 Natural Hazards, namely:
  - Esther Bryant-Lindsay (#4011)
  - Sandra Thomas (#4012)
  - Charles McNeice (#4013) Scott Doherty (#4014), and
  - Bree Le Cren (#4015)

were not included when the submissions on Stage three proposals were notified on 18 September 2015.

- 5. Any further submission must be limited to a matter in support of or in opposition to the submissions and must state whether or not you wish to be heard.
- 6. The further submission must be served on the relevant submitter.
