**BOARD CONSIDERATION**

The Board considered that this subdivision has been designed in conjunction with the Delamain Subdivision to the south, and the Enterprise homes subdivision (Enterprise) to the east. Some of the roads will have common connection points where roads from each subdivision meet. Two roads in the Noble Village subdivision (Noble) will connect with both ends of a crescent shaped road in the Enterprise Homes subdivision. One connection is in the current stage, the second connection will take place at a later stage. It appears logical that the two portions of road in "Noble" should share the same name as the road in "Enterprise" (The layout is important for property numbering and will assist emergency services locating properties.) This road name was approved by the Board on 4 May 2010 as Rannoch Drive.
