

**INTRODUCTION**

1. This submission is made by the University of Canterbury (the University).
2. The University makes submissions in opposition and in support of elements of the proposed Chapter 6 of the Christchurch Replacement District Plan (the Replacement Plan).

**STATEMENT OF INTEREST AND BACKGROUND**

3. The University is one of New Zealand's leading universities. Established in 1873 as Canterbury College in Central Christchurch, it became Canterbury University College in 1933 and the University of Canterbury in 1957. In 1975, it relocated to Ilam and in 2007 it merged with the Christchurch College of Education.
4. The University plays a significant role in the local and regional economy, through the provision of tertiary education and research activities. At 31 December 2013, the University had approximately 12,000 full time equivalent students, 1600 full time staff and 1800 part time staff. Because of this, the University is one of Christchurch's largest employers.
5. The University Campus is some 87ha. It is generally characterised by large scale buildings utilised for teaching, learning and research activities, which are set amongst park-like surroundings. A number of buildings on the Campus were affected by seismic activity, as a result of the Canterbury Earthquakes. Because of this, there is an extensive ongoing campus-wide rebuild and repair program which is anticipated to go beyond 2020 to complete.

**SUBMISSION**

**Submission Summary**

6. The majority of the Campus is zoned Cultural 4 in the operative City Plan, which will be addressed through Phase Two of the Plan review. However, the provisions in Chapter 6 which relate to temporary activities are of significant interest to the University. Within this context the University generally supports the provisions of the temporary activities provisions as notified, but seek minor amendments to provide specifically for the University rebuild program.

7. The detail of the submissions, including the reasons for the submission and the relief sought are included in the table attached as Appendix One. Appendix One should be considered as part of this submission. The provisions relate to Chapter 6 – Temporary Activities, being Rules 6.4.3.2.1 - 6.4.2.2.4.
