Christchurch City Character Areas (formerly special amenity areas)

Character Areas, which used to be known as special amenity areas (or SAMs) will be changed as a result of proposals in stage two of the district plan review. Character Areas are residential parts of the city that contain a set of qualities (eg building style/type/age) that make the area distinctive and of value to the district.

There will be two types of Character Areas:

Category 1 Character Areas have the highest character value.

Rules in the plan seek to retain qualities including the design and look of the house and the type of building that can happen between the house and the street boundary (eg garage location and design).

Category 1 has only one rule. A resource consent will be required for any change proposed to a building or within the front yard of a site that is visible from the street. Things that will be taken into account when considering an application for resource consent are outlined in the proposal that can be seen in the Proposed District Plan Chapter 14 under 14.9.39. As Category 1 Character Areas have a high character value, all of these issues will be considered for each application.



Category 2 Character Areas have moderate character value and the rules mainly seek to retain the streetscape character between the house and the street boundary.

Category 2 has a number of rules (built form standards) that development must comply with. Where a proposed development doesn't meet the rules then a resource consent will be required. The Category 2 rules aim to maintain the quality of the streetscape and open space in the area. There is more detail in the table about the proposed new rules.

The table over the page lists each character area and shows the existing and proposed provisions.
